The Chairman welcomed everybody to the meeting.

49. DECLARATIONS OF INTEREST

Mr B Sabberton-Coe and Mr D Thompson declared their interest as Trustees of the Catton Park Trust.

50. MINUTES OF THE MEETING OF 28.1.2010

It was AGREED that the minutes, which had been circulated, be confirmed as a true record and signed by the Chairman.

51. MATTERS ARISING FROM THE MINUTES

There were none.

The meeting was adjourned for public discussion.

Sergeant Bell gave details of crime in the Village; incidents of criminal damage and rowdy/nuisance behaviour had increased dramatically, mainly during the period between 4th and 15th February. This had taken a lot of police resources but the culprits had been identified and all were being dealt with.

Two of the offending youths, who had been involved with the incident during the Finance and Policy Committee meeting, attended the meeting with a parent and apologised for their actions.

The Chairman thanked the Sergeant who left the meeting with the youths.

It was noted with concern that residents present had also experienced problems with youths and vandalism and rowdy behaviour.

The meeting resumed.
