26. DECLARATIONS OF INTEREST

27. MINUTES OF THE MEETING OF 23.9.2010

It was AGREED that the minutes, which had been circulated with the agenda, be confirmed as a true record and signed by the Chairman.

Mrs G Masdin explained the Committee's proposals for the budget, which would be dealt with in detail at the next meeting. It was unanimously AGREED that the budget be prepared in accordance with these proposals, with a 1.35% increase in the precept.

Mr D Thompson reported that there had been a VAT issue that had cast doubt on the viability of the finances for the education building project which had been satisfactorily resolved and that work had begun on the building.

Mr B Sabberton-Coe reported that the accounts were currently being prepared by Lovewell Blake and would be available soon.

The Chairman thanked everybody for attending and closed the meeting at 8.05 p.m.
